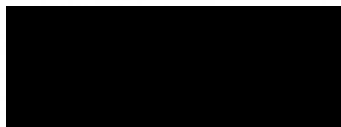
Block Plan

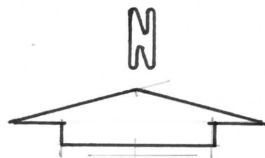

**As Proposed**

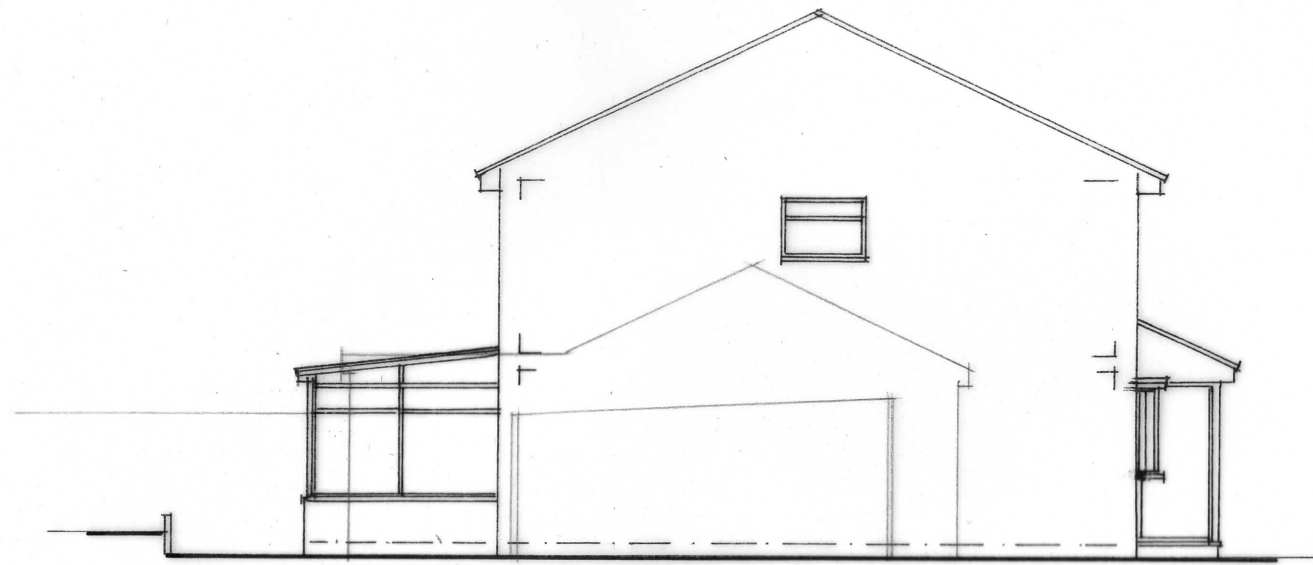
